PERTINENT TOURNAMENT DOCUMENT

ELIGIBILITY

Entries are open to male and female amateur high school and college students. Entries are subject to rejection at anytime. 2020 High School Graduates may elect to enter the College Division.

ENTRY FORM INFORMATION

No Membership Fee is required. The entry fee for each event is \$165.

Online entries will be accepted by the USGA Tournament Management program thru the MGA website: mogolf.org. All events include golf, range balls and automatic entry into event drawings. Online processing requires a credit card. You can enter one tournament at a time or as many as you want but you must be prepared to pay for all selected events. Your name will be entered into the tournament/s selected and you will receive an email confirming your entry. You may enter a tournament online until noon the day before the first day of the event.

Accepted entries may receive a refund of fees if cancellations are made at least one week before the first day of the tournament. After this date, refunds will only be made for injury or illness that has been certified by a doctor's written report and approved for refund by the AGT Tour Administrator. A \$25 service charge will be deducted from each player's refund. If a player qualifies for a national event, reschedule as soon as possible. There is no charge to change your schedule of events.

Entry fee does not include practice round green fee. Players may contact the event facility for the availability and cost of practice rounds.

TOURNAMENT FORMAT and REQUIREMENTS

Two 18-hole stroke play competitions played over two days. 100 players per event will be accepted. Divisions: College Men/Women; High School Men/Women Register upon arrival each day. Caddies are not permitted.

TOURNAMENT TRANSPORTATION

Players must walk at all times during a stipulated round. The optional condition prescribed in Appendix I of the Rules of Golf will be in effect. Any player seeking a golf cart due to a disability as defined under the Americans with Disabilities Act (ADA) should log onto www.acceleratedgolf.org or contact the Tour Administrator Carol Fromuth to obtain information on procedures for submitting such requests.

All requests with required information must be submitted to the AGT simultaneously and together with the original entry application in writing, and received by the AGT Tour Administrator no later than one month prior to the first day of the first event that is entered. Facsimile, phone or online submissions FOR THIS REQUEST FOR CART not accepted.

Requests due to temporary injuries or impairments that do not qualify as a "disability" under the ADA will not be granted. Carts for players available only for those who are ADA-qualified.

PACE OF PLAY

At each competition, the Tournament Committee will determine the maximum allotted time each group is permitted to play the stipulated round. The stipulated round is complete when the last player in the group completes play of the final hole and the flagstick is securely in the last hole played.

COURSE SET UP

The AGT will monitor the yardage set up for the courses on a day-to-day basis. Changes may be made as a result of weather conditions or unforeseen problems.

PLAYER CODE OF CONDUCT

Inappropriate behavior by any junior, witnessed by our staff, fellow competitor, or employee of the host facility will result in the player immediately being disqualified from the current event and their next event without a refund. Inappropriate behavior could include, but is not limited to: the use of improper language, dressing in non-golf attire, throwing clubs, damaging the course, failure to repair ball marks on the greens or replace divots on the course, cheating, talking while a fellow competitor is playing a shot, knowingly violating the rules of golf, affecting play of another, overall display of poor sportsmanship or the use of tobacco, alcohol or illegal drugs.

DRESS CODE

All: blue denim apparel is prohibited. Soft spikes are required.

Female Contestants: skorts, tailored slacks or bermuda shorts. Tight or short shorts/skorts, tight slacks and or tank/tank-like tops or cropped shirts (above the waist) are prohibited.

Male Contestants: shorts or slacks, collared or mock turtle neck shirts. Shirts must be tucked in.

Parents and Spectators: collared or mock turtle neck shirt, no athletic attire (sweat suits, gym shorts, tee shirts), no denim pants or shorts. This dress code will be strictly enforced by the AGT staff.

EVENT PRIZES Prizes this year will be gift certificates.

If 4 or fewer players, payoffs will be determined by the Tour Administrator. (If gift certificates are not allowed, trophies will be awarded.)

PLAYER OF THE YEAR

Players will accumulate points throughout the current scheduled events. At the conclusion of the year, the winners of each of the four AGT Divisions will be recognized. Players must play in minimum of three tournaments to be eligible for player of the year. A maximum of five tournament points will be used.

Points will be awarded for finishing 1st through 8th accordingly:

PRACTICE ROUNDS

If a club allows a practice round for AGT players, it will be included in the event information on the Tournament page for that club. Please consult that web page for up to date information.

PUBLICITY, PROMOTION and BROADCASTING

The AGT may arrange for promotion of all events for radio, television, broadcasting and other exhibition and publication, including the AGT Website. By this application, the player consents to the use by the AGT, or persons authorized by the AGT of the player's name, likeness, voice and references to all photographs and other images connected with the player's appearance in these events or any portion(s) thereof, in connection with such media promotion, broadcasting and other exhibition and publication.

REQUESTING A GOLF CART FOR AGT COMPETITIONS

As a general rule, players must walk the course at AGT events. Consistent with the Americans with Disabilities Act (ADA), a disabled player may be permitted to use a golf cart as an accommodation to her disability for those events where golf carts are not allowed. As required by the ADA, the AGT will evaluate such requests on a case-by-case basis.

In order for the AGT to properly evaluate the merits of such requests, while maintaining the fundamental fairness of the golf competition, it is necessary for players requesting this accommodation to submit medical documentation to facilitate that analysis. The documentation provided must demonstrate: (1) a player's disability as defined by the ADA (temporary conditions may not be covered); (2) the medical need for the golf cart that results from that disability; and (3) that by providing a golf cart to a player in that particular circumstances, the AGT would not be fundamentally altering the fairness of the competition by providing a player with an advantage over other players. The required form entitled Golf Cart Request Form (as well as additional important information for first-time and subsequent requests for a cart), is available on our website following this document.

In order to permit the AGT to undertake the necessary analysis and make arrangements for golf cart usage where approved, all in time for the relevant event, players must strictly comply with each of the following procedures. Any failure to comply with any of these procedures may result in a denial of the requested accommodation.

- Requests for golf carts must be supported by complete documentation, including the fully-completed Cart Request Form and the required accompanying medical documentation specified in that form for all first time requests. A request will not be deemed complete until all required information and documentation has been provided.
- If the player has previously executed a stipulation governing the use of a golf cart during a USGA or a AGT championship, the player is not required to submit the Cart Request Form and medical documentation again. The previously executed stipulation may govern the use of the golf cart if the intended use is in the same capacity.
- In some instances, even with an executed Stipulation from a prior event season, that stipulation may have been effective only for the specific season. In all cases relating to a previously executed stipulation, the player **MUST** contact the AGT (Carol Fromuth 314-434-6306) and provide a copy of the fully executed stipulation. Except for minors, all requests for golf carts must be made by the player. For minors, only parents or legally-appointed guardians may submit a request for a golf cart.
- In the event of a change of medical condition for the player after the submission of the entry or after the initial submission of the required documentation, medical documentation of all relevant changes must be received no later than seven (7) days in advance of the event proper for which the golf cart is requested. Telephone requests as submissions will not be accepted under any circumstances at any time.
- All information submitted in connection with the golf cart request should be sent to comply with the timing deadline stated in the previous paragraph, to the attention of the Tour Administrator, Carol Fromuth, 1504 Kehrs Mill Road, Chesterfield, MO 63005.
- If any player needs assistance with any part of the process for requesting a golf cart, including any reasonable accommodation, contact the Tour Administrator, Carol Fromuth at 314-494-6306.

- b) The extent of the disability,
- c) The prognosis for improvement,
- d) The current objective abnormalities and how it impedes upon your ability to walk in general and during a golf tournament,
- e) How far you are able to walk without stopping,
- f) What prohibits you from walking further,
- g) How long you are able to stand,
- h) Whether you use ambulatory aids and if so, the length of time and circumstances under which these aides are used.

Please explain the nature and history of your disability and why it requires that you use a golf cart.

What treatment are you currently receiving as it relates to your ability to walk?

What is the expected duration of your disability?

If your condition relates to a cardiac (heart) problem, do you take cardiac medications?

If so, what are the medications?

Do you experience shortness of breath, chest or arm tightness, leg cramping while walking?

If so, how many yards can you walk before stopping?

Have you ever been given an impairment rating for a disability of medical condition that relates to the disability that led to the cart request?

If so, please provide details as to the rating, basis for the rating (AMA Guides to Permanent Impairment, 6th edition, or to a local or state rating guide) and any other relevant information not already provided by you or your physician.

As part of the review process by the AGT, please discuss with your physician what additional information pertaining to your ability to walk the course can be provided by your physician to the AGT for review (such as a summary of surgeries, diagnostic studies, laboratory tests, treatments, medications, clinical notes and other relevant medical information specific to the diagnosis and management of the disability) and submit any such information that you or your physician believe would help the AGT assess the degree of your impairment with the physician's medical report.

AGT COVID-19 EVENT POLICIES



The AGT reserves the right to adapt any of the following guidelines to protect the health and safety of players, spectators, AGT Staff, host facility staff and volunteers



General Guidelines

- Do NOT play if you feel sick or have been in contact with someone who has tested positive for COVID-19 within the last 14 days
- Players feeling ill after the deadline, a full refund will be given
- Maintain proper social distancing at all times
- If a player becomes ill after playing in an AGT event, please call Carol Fromuth 314-494-6306 immediately

Player Responsibilities

- Bring necessary hand sanitizer and/or mask and gloves, they will not be provided
Bring your own water and/or snacks
- Avoid sharing of paperwork, tees, etc.
- Avoid overcrowding of restroom facilities

Driving Range/Practice Areas

- Players may only practice within one hour of their starting time
- Limit warm-up time to maintain social distancing on the practice facilities
- ONLY players are allowed on practice areas
- Practice Areas may be prohibited/limited after a round

Caddies/ADA Cart Guidelines

- ADA Carts will be limited to ONE player per cart
- **No Caddies will be allowed**

Starting

- Maintain appropriate distance from starter
- Players will be given a scorecard for another player in your group by the starter. DO NOT trade scorecards (see Scoring)
- Starter will sanitize their hands between each group
- Players may come to their 1st Tee ONLY after the preceding group has left the Teeing Area
- Starter Box items such as tees, pencils and sharpies will not be available
- A Notice to Players and Hole Locations sheets will be provided by the Starter

During the Round

- Maintain social distancing throughout the round
- Do not touch/remove flagsticks
- Do not touch equipment of other players
- Bunkers: use your feet and/or club to smooth
- Weather Delays: We will be more proactive in suspending play for a dangerous situation to give players plenty of time to seek shelter; during delays players will be asked to return to their vehicle; players will be updated via text messages.

Scoring

- Maintain social distancing in/around the scoring area (players ONLY will be allowed in scoring area)
- Players will have another player's scorecard to keep scores with the marker strip to keep their own scores
- ONE player in each group will use the USGA TM/Golf Genius scoring app to input scores during the round for the group
- Scoring Area Procedure:
 - Scoring Official will ask each player to read the scores of the player for whom they marked
 - The player will verbally confirm the hole-by-hole scores
 - Scoring Official will input scores into computer
 - This process will continue until all scores for group are confirmed
 - Players will place scorecards in a box and scoring will be complete, no signatures will be required

Volunteer/Staff Procedures

- Rules Volunteers/Staff will be required to maintain social distancing guidelines with players
- Rules Volunteers/Staff will each have their own cart
- Rules Volunteers/Staff will have bottled water available on their carts on the course

AGT Staff Operational Policies

- AGT Reserves the right to make any changes, updates to these policies and guidelines before or during an event
- Staff will sanitize course equipment: radios, computers, tee markers, etc.

Please check the AGT Website for all updates to our policies should they change during the season.
